The van and 30-meter extension cable are both PAT tested but please be aware to serve you for any length of time we may need access to a domestic 240v 13amp power supply.

If a generator is the power source, we require it to cope with 25amp on start-up and a running 12amp usage.

Rosie the van

The van and 30-meter extension cable are both PAT tested, it is unlikely we will need power if serving for a day but if any longer we would need access to a domestic 240v 13amp power source.

If a generator is to be the power source, we will need it to manage 20amp on start-up and a running 5amp usage.

All staff will all have a valid DBS certificate, and the vehicles have a 5* hygiene certificate from the local Council and the relevant public liability insurances in place.

Our terms and conditions are recorded below, please read and familiarise.

Terms and Conditions of business of Indulgent Ice Creams.

1. A booking will be confirmed with Indulgent Ice Creams when both the booking fee has been received and the booking form has been signed and returned. A non-refundable booking fee of £100 per will secure the vehicle on the agreed date and time. The deposit is required at the time of booking. Prior to a booking fee and or booking form being received by the Hirer Indulgent Ice Creams can formally and in writing withdraw the quote.

3. A written confirmation of the booking will be emailed as a receipt of both the deposit and signed booking form. Any outstanding balance is required to be paid no later than 30 days before the event/party/ wedding. If full payment is not received 7 clear days before the ceremony/event we consider you have breached our terms and conditions and we reserve the right to not attend, you will forfeit any deposit received. We will not accept cash payments on the day of the event.

3. Any cancellations must be made in writing to Indulgent Ice Creams. All cancellations will incur a charge. (The minimum is the booking fee of £100). Should the Hirer cancel within 30 days of the agreed booking date, then the outstanding balance is the full agreed booking, minus the deposit and is still required to be paid in full. In the event that we secure another booking for the vehicle for the same date all monies will be refunded, minus the £100 booking fee.

4. In the event of the Hirer changing the date of a confirmed booking we will transfer the booking fee to the new date subject to availability. However, if the new date is unavailable the Hirer will forfeit the booking fee of £100.

5. In the event that the Hirer changes the date within 30 clear days of the original agreed booking date, if the new date required is unavailable; then the full balance of the original hire will still be due in full.

6. Whilst every effort is made to provide the vehicle booked Indulgent Ice Creams cannot accepted any liability for unforeseen mechanical failure or any other circumstances beyond our control. In the rare occasion this occurs we will swap to our other van if available.

In the extremely unlikely event of a delay leading to a missed booking, a full refund will be offered, as long as it can have been proven and accepted that Indulgent Ice Creams are deemed to be wholly responsible.

7. All our vehicles and operatives will be immaculately presented; all staff hold a current DBS certificate. Our ice cream van holds a current food hygiene certificate issued by the local regulatory authority. Special requests can be considered at an additional cost.

8. We understand the complexities of the day and timings involved and our staff are likely to arrive slightly earlier than the specified arrival. Any subsequent delay in accessing our services will not be deemed to be the responsibility of Indulgent Ice Creams and the hire period starts and ends at the agreed times on the signed booking form. The ice cream van will depart at the specified departure time as recorded in your confirmation letter.

9. Indulgent Ice Creams cannot be held responsible if the booking is completely missed due to the time keeping of the hirer.

10. We have quoted a price on the information provided at the time of booking and have calculated the time required for your event/party. We have been generous in our estimates; however, in the rare event that a significant amount of extra time be required an additional charge may be made proportionate to the original booking quote. Should the event/party/ wedding significantly over run for a reason outside your control no extra charge will be made.

11. Indulgent Ice Creams will choose the route(s) to your event/party based on local knowledge and or satellite navigation. The drivers will use their judgement driving at a lawful and sensible speed in relation to the road and weather conditions.

12. Whilst every effort will be made to arrive at scheduled locations in good time, no responsibility can be taken for unforeseen road closures or for restrictions relating to vehicle access to any location or unforeseen physical hold ups on route to the event or adverse weather conditions. We cannot be held responsible for late arrival or cancellation due to any other circumstances beyond our control.

13. The Hirer is responsible for any accidental or intentional damage caused to the vehicle(s) by themselves and or their guests. A minimum charge of £100 will be charged to cover the valet costs should damage be caused by any guest through drink, food or illness.

14. No responsibility will be taken for any loss or damage to any personal possession of any guest of the hirer. Unless negligence or recklessness can be proven. Every effort will be made by our staff to reunite any property found to be the members of the Hirer's party.

15. Indulgent Ice Creams cannot be held responsible for any adverse medical reaction or allergy to anything consumed or subsequently later or any injury or loss caused

through excess consumption of our products. A written warning sign and a disclaimer will be displayed in relation to gluten and dairy intolerances. We have never knowingly had our products near any nut-based product and always advise that any guest who has any intolerance notifies and checks with staff of Indulgent Ice Creams before consumption.

Indulgent Ice Creams cannot be held responsible if in the Hirer's opinion insufficient ice creams were consumed due to adverse weather conditions on the day of the hire. As required Indulgent Ice Creams will attend any wedding, event, or party until either the Hirer cancels, on the day or any day before, of the event, wedding, party where no refund will be offered unless we can resell the date with a comparable event, wedding, party. If Indulgent Ice Creams cancel, as we consider it is unsafe to attend, a full refund will be offered. In all cases we will do our best to attend.

Indulgent Ice Creams cannot be held responsible by the Hirer if in the Hirer's opinion insufficient ice creams were not consumed due to adverse weather conditions on the day of the hire.

As required Indulgent Ice Creams will attend any wedding, event, or party until either the Hirer cancels, on the day or any day before, no refund will be offered unless we can resell the date with a comparable event/wedding/party.

If Indulgent Ice Creams cancel as we consider it is unsafe to attend a full refund will be offered.

In all cases we will do our best to attend.

16. Indulgent Ice Creams may take photographs for their own promotional use; they may appear on our social media sites and by signing these conditions the Hirer has given Indulgent Ice Creams permission to do so.

17. Cancellations are always a disappointment, we will do everything in our power to prevent them being our responsibility, however, Indulgent Ice Creams cannot accept responsibility for any unforeseen electrical failure that prevents the freezers charging, i.e power cut or any inclement, wet, or windy weather that makes what we consider our attendance to be hazardous. We reserve the right to cancel. If the event/party is cancelled by the hirer at any time prior to the event/party no refund is due. If the event/party is cancelled by Indulgent Ice Creams a refund will be offered.

18. Indulgent Ice Creams reserve the right to withdraw the unlimited option of servings at any event/party or wedding if it is felt by the member of staff present that an individual or group/s of individuals are taking advantage of the offer and are having an excessive and unduly large quantity or engaging in or encouraging others to engage in an activity that results in an excessive quantity of ice creams or sorbets to be consumed during the hire period.

This clause will not be activated lightly and only in extreme or exceptional cases.

19. We reserve the right to amend our terms and Conditions at any time. But only the agreed terms at the time of signing are applicable.

20. As you will be aware the new General Data Protection Regulation (GDPR) comes into force on the 25th May 2018.
